I am going to officially participate in the **World Outdoor Tug of War Championships** (hereinafter *the championship*) called by the TWIF that will take place from 16 to 19 September 2021 at the Fadura facilities in the town of Getxo (Basque Country), organized by the local organization *Asociación Soka Tira Getxo 2020*, with the logistical support of *Viajes Azul Marino*,

And for the purposes of which I declare to:

- Meet the admission requirements set out by the TWIF.
- Have read and accepted the documents provided by the local organization on the adaptation of the championship to COVID-19 (see Plan Covid\_v1.en, and Q&A)
- Understand to be attending a championship within a "bubble group" and that in the event the "the bubble is broken" they must leave the championship without any total or partial right to compensation for the services offered.
- Having had been subjected to a PCR test no more than 72 hours before the arrival at the official hotel and that its result has been negative, except people who have had Covid 19 at least 15 days ago and not more than 6 months ago.
- Accept to be subject to an antigens test on arrival at the official hotel and in the event that it is positive to be immediately subjected to a PCR test. And the event the PCR test is positive, to be isolated and not be able to compete.
- Have travel insurance that covers among other things the medical assistance for Covid.
- Accept to be subjected every day to a body temperature measurement on entry to Fadura, and in the event that it is over 37.5° to be isolated and subjected to a PCR test
- Agree that during the championship photographs and videos may be taken of me during the course of the competition in Fadura, and that the images may be used by the organization for their subsequent sale or promotion of the results of the championship.

- III. How we collect your personal data: Information that you provide to us through our website, through forms or fields to be completed, registration for our newsletter or through email.
- IV. Conservation periods: The personal data provided will be kept and processed to the extent that we need them in order to be able to use them according to the purpose for which they were collected and according to the legal basis for their processing in accordance with the applicable law. We will keep your personal data while there is a relationship or until you exercise your right to deletion, cancellation and/or limitation of the processing of your data. In these cases, we will block your data, without using them, while it is necessary for the exercise or defence of claims or while any type of legal or contractual liability may derive from your processing, which must be met and for which their recovery is necessary.
- V. Recipients of the personal data communication: Viajes Azul Marino and Asociación Soka Tira Getxo 2020 communicates the personal data to service providers that may act as data processors. These third parties have only access to the personal data necessary to perform the service. They will be required to keep your personal information confidential and they are not able to use them in any other way different to that for which we have requested them.

1. What are your rights in connection with the processing of your data?
    - Right to request access to your personal data
    - Right to request their rectification or deletion.
    - The right to request the limitation of their processing
    - Right to oppose the processing
    - The right to the portability of the data
    - Right to withdraw the consent provided
  2. Do you have the right to withdraw your consent? The interested party has the right to withdraw at any time the consent provided without this affecting the lawfulness of the processing based on the consent provided at the time from their subscriptions or provision of data.
